New roundabout (Wadsworth and Dilleys) construction to commence summer 2020 with the intersection closed from July through September. We discussed details and timing of the project and provided information on project contacts and the complaint submission process during construction.

## Secretary / Chris Kirkham -

Not Present.

#### Treasurer / Randy Housner-

Presented the actuals from 2019. Revenue exceeded budget and we collected \$900 interest on a \$50k CD. Landscaping, pond maintenance, and mosquito abatement continued to be the largest expenses for 2019. We have approximately \$85,000 in the reserve fund which has doubled in the past 5 years. Need to maintain surplus in the event we ever need to dredge a drainage pond. There is an approximately \$500 yearly electric expense for the light at the mailbox hut. It was reported that The Willows has made use of solar powered lighting, so James volunteered to contact members from The Willows and investigate the viability of using solar powered lighting at the hut. He also reported on the painting of the hut and entrance signs. Motion and second to approve 2019 budget.
